### **Additional Speaker Biographies**

### Kevin Miller:

The presentation will inform the audience of the New York State Department of Transportation's Sustainability Program. The NYSDOT is a national leader for transportation sustainability developing the GreenLITES program to provide sustainability assessments for its projects, operations and maintenance activities. This program is similar to the LEED program for buildings. Discussed will be the NYSDOT's history of environmental stewardship leading up to its current effort to assure a sustainable transportation system for the current and future users of the system. It will cover the transition of the NYSDOT from construction of the Interstate Highway System to its current task of operating an intelligent multi-modal transportation system to support our economic and recreational lifestyle choices without compromising the ability for future generations to pursue the same goals.

### **Enid Cardinal:**

Enid Cardinal is the Rochester Institute of Technology's senior sustainability advisor to RIT President Bill Destler. Cardinal is a LEED-accredited professional with a background in socially responsible investing and environmental policy.

### Kurt Duska:

Kurt Duska is the President and Owner of Engineered Plastics Inc., a firm with 3 facilities totaling 200,000 square feet and 175 employees. He is a founding member of both the Healthcare Plastics Recycling Council and the Pennsylvania Recycling Markets Center. In addition, he started a medical recycling program at the Cleveland Clinic. Mr. Duska has achieved success with 25 years experience in Tooling, Molding and Assembly. He holds a BS in Industrial Engineering from Gannon University in 1997. Among his many accomplishments, Mr. Duska was awarded Pennsylvania Governor's Award for Environmental Excellence.
